Delivery:

Delivery times may vary from 1 day up to 1 week depending on the destination, your local custom processing times, payment terms and the shipping company.

Please note that you are responsible for all shipping charges, taxes, duties or other customs fees assessed in the country of delivery. You are also responsible for ensuring that the items you ordered can be imported legally into your country. If your order is refused by local customs and returned intact to CMC Tasly Group BV, we will refund your original order amount (less any delivery charges).

Additional charges may be applied if the delivery address is incorrect, if the packages needs to be forwarded to a different location or when packages are returned to us.

The parcels will be delivered by DPD or DHL from Monday to Friday (please send us an request for a Saturday delivery). If you are not at home the delivery company will try to deliver your order to the neighbors or to a parcel shop. You can pick up the parcel within 7 days, we have to charge additional costs when parcels are not picked up in 7 days.

Please note: As an importer you must comply with all applicable regulatory of your country.

You will receive a track & trace email from DPD or DHL on the day of shipping.

What makes Predict of DPD so special?

- 1. You'll receive a message from DPD on the day of delivery. This message specifies a one-hour period within which your parcel will be delivered.
- 2. If your plans change and you won't be at home? Then you can easily adjust the time or place of delivery online. You can also choose to have your parcel delivered to a parcelshop.
